
This firm represents Jonelle Eshbach. I have been provided with the unprofessional and harassing email you sent Attorney Eshbach on Sunday, August 17, 2014 at 2:32 AM regarding the "Sandusy" case. I have attached a copy of your email for reference by the authorities.

You are specifically advised that you, or anyone acting on your behalf, must cease all communication with Jonelle Eshbach and her family. Stated simply, you should not have ANY further contact with Attorney Eshbach and her family. Contact is defined as in-person, via telephone, correspondence, or by any electronic media (including email and any form of social media), at any location, in any way, shape, manner or form. I have advised my client not to hesitate to contact the police in the future should any harassing communications be initiated by you or those acting on your behalf. Additionally, please be advised that any further communication or harassment by you or anyone on your behalf will result in the initiation of criminal charges against you for the offense of Harassment and Stalking, 18 Pa.C.S.A. 2709, Harassment by Communication or Address 18 Pa.C.S.A. 5504, Maryland Code Section 3-805 - Misuse of Electronic Mail, or Section 3-803 - Harassment.

Please govern yourself accordingly.
